I INTRODUCTION

This report presents an analysis of central government expenditure from January 1st – January 31st, 2023. The purpose of this report is to inform all relevant stakeholders on the composition of Government Local Fund (GLF) expenditure for the period under review highlighting in particular, the expenditure rates of different Budget Entities (BEs) and different budget line items.

This report also indicates prior year comparatives and spending patterns. It should be noted that all expenditure herein refers exclusively to GLF denominated in Gambian Dalasi (GMD) and does not factor any donor sourced funding including external loans and donor project grants.

Key things to note;

- 1. The overall GLF expenditure is 8% of 2023 GLF budget.
- 2. Personnel Emoluments and Capital expenditure (31% and 27% respectively) constitute the highest expenditure classes during the period.
- The Ministry of Transport, Works and Infrastructure is the top spending BE with 24% of the total expenditure for January. This is as a result of high spending on Roads and Bridges budget line (25% of its 2023 approved budget).
- 4. It is important to note that 38% of the approved budget for Input Subsidy has been allocated to the Ministry of Agriculture.

II TOTAL GOVERNMENT EXPENDITURE

Government's total expenditure for the month of January amounted to **GMD 1.77 billion** as compared to GMD 1.24 billion during the same period last year, representing a **42% increase** in total GLF spending. This upward trend in total expenditure is attributable to significant Year-onYear (Y-o-Y) increases in Other Recurrent Expenditure (37%), Debt Service (707%) and Capital Expenditure (7,721%).

Details of government spending by economic class is given in Table 1 below.

Table 2 compares the actual spending by economic classes against the Approved 2023 National Budget, highlighting the expenditure rates. Personnel Emoluments (PE) expenditure amounting to GMD 6.10 billion has been approved, and a total amount of GMD 554.30 million has been spent in the month of January, representing a 9% spending rate. Other Recurrent expenditure amounting to GMD 5.39 billion has been approved, and a total amount of GMD 229.91 million has been spent, representing a 4% spending rate. Subventions amounting to GMD 3.70 billion have been approved, and a total amount of GMD 363.38 million has been spent, representing a 10% expenditure rate. Debt Service expenditure amounting to GMD 4.30 billion has been approved, and a total amount of GMD 301.39 million has been spent, representing a 7% spending rate. Meanwhile, Capital expenditure amounting to GMD 2.50 billion has been approved and a total amount of GMD 472.80 million has been spent representing a 19% budget absorption rate. Capital Expenditure is the highest spending economic class, and this is mainly attributed to the numerous road projects and health facility constructions across the country.

During the month of January, total PE increased by **32** % to reach **GMD 554.30 million** compared to GMD 419.90 million from the same period last year. Basic Salary grew 49% y-o-y, Allowances grew 15% y-o-y and Exchange Concession Allowance (ECA) grew 55% y-o-y. There were no registered Staff Loans or Social Security Contributions for civil servants during the month of January. Basic Salary accounted for 44% of total PE expenditure during January, and Allowances have accounted for 50% of total PE expenditure. The remaining 6% is ECA spending.

The increase in PE spending may be attributed to the 30% increase in Basic Salary from the Revised 2022 Budget, and also the introduction of the two new Ministries – the Ministry of Communications and Digital Economy, and the Ministry of Public Service, Administrative Reforms, Policy Coordination and Service Delivery.

<u>Table 3A</u> details the Approved 2023 Budget for PE as compared to end-January expenditure. ECA has accounted for 12% of its approved budget, whilst Basic Salary and Allowances have each accounted for 9% each of their approved budgets. In total, PE accounted for 9% of its approved budget.

III. Top Spending Budget Entities (BEs) in January


The Ministry of Works and National Debt Service top the list of the highest spending BEs, respectively consuming 24% and 17% of total expenditure for the period under review. Following these are Ministry of Basic and Secondary Education at 15%.

These ten Bes, account for **GMD 1.63 billion** of total expenditure for January 2023.

IV. Top Ten Spending Budget Lines

Roads and Bridges is the highest spending budget line during the period under review, amounting to GMD 404.65 million, and registering a 25% spending on its approved budget. This is followed by Subvention with an amount of GMD 393.05 million at 11% of the approved 2023 budget.

It is important to note here that, the Input Subsidy budget line is now expensed by the Ministry of Agriculture.

As compared to last year, spending on all budget line items have increased except for Input Subsidy and Operating Cost.

A summary of highest spending budget lines is provided in <u>Table 4</u> below.
